- 6. Please register the correct and complete Bank details with us for all your Folios to facilitate prompt electronic credit of dividend / interest / redemption amounts and eliminate possibility of unclaimed amounts / underlying securities being transferred to IEPF.
- 7. Promptly inform us in writing and complete required formalities in case of loss of securities.
- 8. Ensure that the documents provided for availing any investor service request are complete in all respects and keep copies of documents sent to us.
- 9. Monitor all corporate announcements pertaining to investments made.
